 election April 7 May 17. Kate Elkins and Katie Perkowski are coordinating the AAUW Carlisle project to make sure you are
 informed and vote.

National dues increase

AAUW members received an email on October 30th from Julia Brown, AAUW Board Chair, announcing an increase in Individual Member dues for the next three years. The dues will rise by \$3 for Fiscal Year (FY) 2022, \$5 for FY 2023, and \$5 for FY 2024, making the total dues amount for those years \$62, \$67 and \$72, respectively. "In order to preserve the viability of this organization we all love, the board needed to take action. Simply put, this measure is essential for AAUW to continue our mission to achieve gender equity."

This spring, the AAUW membership will vote on an important proposal to amend the AAUW bylaws to open membership and eliminate the degree requirement to join AAUW. The AAUW Board of Directors believe this is an essential step toward making AAUW a more diverse and inclusive organization, better aligned with our mission, values and the needs of women today.

PUBLIC POLICY UPDATE

Education Funding in Pennsylvania: Inadequate, Inequitable & Unconstitutional

The above title was that of a recent webinar presented by Education Law Center (an organization dedicated to fostering equal access to education for all children in Pennsylvania) and Public Interest Law Center (an organization based in Philadelphia that addresses civil, social and economic rights for communities in Philadelphia facing discrimination, inequality and poverty.)



What makes education funding in Pennsylvania inadequate, inequitable and unconstitutional? To begin with, Pennsylvania trails far behind other states in terms of the state contribution to education; meaning our schools get less funding from the state in general. Specifically, schools in districts with high poverty rates (such as Reading, PA) can have funding differences per child annually that are \$13K less than a wealthy school district (such as New Hope-Solebury.) Though this difference occurs due to discrepancies between both local and state revenues towards education, it does not represent a lack of effort on the part of local government. Tax rates in Reading are nearly twice that of those in New Hope-Solebury – meaning the populace of a school district like Reading with a 90% student poverty rate is also burdened with much higher taxes while their schools remain underfunded.

In terms of inequity, Pennsylvania's school districts are among the most segregated by race and class lines of anywhere in the nation, and Pennsylvania has larger gaps in student outcomes by race than almost any other state. Districts receiving the most revenue are disproportionately white, while the districts receiving the least revenue are disproportionately Black and Latino. Underfunded schools have larger class sizes, insufficient space, a lack of technology and school supplies, inexperienced teachers with high turnover, outdated buildings with maintenance issues, low test scores and poorer student outcomes.

What makes this situation unconstitutional? Article III, Section 14 of the Constitution of the Commonwealth of Pennsylvania asserts "The General Assembly shall provide for the maintenance and support of a thorough and efficient system of public education to serve the needs of the Commonwealth." Inadequate funding of school districts does not reflect a thorough and efficient system and further, the inequity between poor and wealthy school districts reflects discriminatory practices that deny full and equal access to thorough education for children in poor districts.

In 2014, Education Law Center along with Public Interest Law Center filed a lawsuit (*William Penn School District, et al. v. Pennsylvania Dept. of Education, et al*) on behalf of six school districts, seven parents, the Pennsylvania Association of Rural and Small Schools (PARSS) and the NAACP Pennsylvania State Conference against legislative leaders, state education officials, and the Governor, asking for a court order that will force the legislature to comply with the state constitution and ensure all students receive access to a high-quality public education.

A 2016 enactment of a "Fair Funding Formula" by the Pennsylvania State Legislature that determines a district's share of funding based on student and district characteristics seemed to attempt to address the inequities in the current funding system. However, when enacted, a provision in the formula meant that it is only applied to new funding – meaning only 8.83% of the education funding was filtered through this formula last year, leaving the majority of funding entrenched in the current inequitable practices. One recent study found that Pennsylvania school districts with the fewest white students are shortchanged in state funding by almost \$2000 per pupil, while the districts with the most white students receive about \$2000 more per pupil than their fair share under the funding formula.

William Penn School District, et al. v. Pennsylvania Dept. of Education, et al is expected to go to trial early in 2021. PUBLIC POLICY UPDATE

Forget Topic Talks, Ladies. It's time for Topic Walks!

That's right. I'm sure we have all been enjoying the wonderful impact that COVID-19 has had on our waistlines. Whether stress eating, baking for entertainment, or hey, just sitting around because there is nowhere to go, it's hard to combat the stasis of staying home. But with Spring just around the corner (and hopefully vaccinations for all), we on the Public Policy committee have been thinking about ways to get together safely and in person. So, here's the idea!

Typically, we host Topic Talks to explore a public policy issue in depth in a book group format. Participants read relevant materials prior to the event, and then meet in a member's home with an expert in the field who moderates a discussion. A Topic Walk, COVID-19 style, is a bit different. The "host" of the walk chooses a topic and assembles a short list of short articles (3-5) sent via an email with links. Participants are asked to read at least one article to have some point of discussion on the topic. (Have you noticed we're keeping our expectations low?) In order to maintain social distancing, topic talk groups should be no more than eight people – four to six people might be preferred.

We will meet in a park with a walking path and outdoor seating option, like a picnic shelter. We introduce the topic once we are gathered along with a few guiding questions to start a discussion, then go on our walk, breaking into groups of two to "pair and share" while adequately socially distanced. Then, once we return to the seating area we have a short group discussion to cross-pollinate our ideas. For maximum safety, we stay masked up throughout – being outdoors, masked, and maintaining social distance is the best way to mitigate risk!

A few of us on the public policy committee did a dry run of a Topic Walk last weekend and it was low-key, grand fun! Seeing real, live people! We walked on the Dickinson Trail, which was great - there are several other options in the area (LeTort Park, Thornwald Park, etc.) to try out as well. So as things warm up, keep an eye out for Topic Walks.
